

SUMMARY ANNUAL REPORT

For Beer Industry Local Union No. 703 Health & Welfare Fund

This is a summary of the annual report of the Beer Industry Local Union No. 703 Health & Welfare Fund, EIN 36-6051305, Plan No. 501, for period January 1, 2021 through December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan sponsor has committed itself to pay all of the medical claims incurred under the terms of the Plan.

Insurance Information

The plan has contracts with Amalgamated Life Insurance Company and The Union Labor Life Insurance Company to pay life insurance and stop loss claims incurred under the terms of the plan. The total premiums paid for the contract years ending May 31, 2021 and December 31, 2021 were \$302,956.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$17,692,790 as of December 31, 2021, compared to \$18,011,196 as of January 1, 2021. During the plan year the plan experienced a decrease in its net assets of \$318,406. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$5,775,018, including employer contributions of \$3,846,817, employee contributions of \$829,011, realized losses of (\$170,788) from the sale of assets, earnings from investments of \$1,256,172, and other income of \$13,806.

Plan expenses were \$6,093,424. These expenses included \$804,554 in administrative expenses, and \$5,288,870 in benefits paid to participants and beneficiaries.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
