

## **SUMMARY ANNUAL REPORT**

### **For BEER INDUSTRY - LOCAL UNION NO. 703 INDIVIDUAL ACCOUNT PLAN**

This is a summary of the annual report for Beer Industry – Local Union No. 703 Individual Account Plan, EIN 36-6522619, Plan No. 002, for period January 01, 2020 through December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic Financial Statement**

Benefits under the plan are provided by a trust fund. Plan expenses were \$589,290. These expenses included \$17,304 in administrative expenses, and \$571,986 in benefits paid to participants and beneficiaries. A total of 960 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$9,407,999 as of December 31, 2020, compared to \$8,833,830 as of January 01, 2020. During the plan year the plan experienced an increase in its net assets of \$574,169. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,163,459, including employer contributions of \$264,877, and earnings from investments of \$898,582 .

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (Beer Industry – Local Union No. 703 Individual Account Plan, 18660 Graphic Drive Suite 202, Tinley Park, IL 60477) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
